BYLAW NUMBER 2000-223

A BYLAW FOR THE PURPOSE OF GRANTING EXEMPTION FROM TAXATION TO CERTAIN PARCELS OF LAND AND IMPROVEMENTS AS PROVIDED FOR UNDER THE COMMUNITY CHARTER

The Municipal Council of The Corporation of the District of Summerland, in open meeting assembled, enacts as follows:

1. That the following described land and improvements located thereon, be and are hereby exempted from taxation for the year 2006 pursuant to Section 220(1) of the Community Charter:
 - a) **Roll Number 00655.000**

Lot 1, District Lot 455, Plan 791, Osoyoos Division Yale District; this property being the property occupied by St. Andrew Presbyterian Church.
 - b) **Roll Number 00845.005**

Lot "B", District Lot 473, Plan 29303, Osoyoos Division Yale District; this property being the property occupied by the Pentecostal Assembly of Canada.
 - c) **Roll Number 00885.000 and Roll Number 00886.000**

Lots 21 and 22, Block "B", District Lot 473, Plan 1133, Osoyoos Division Yale District; this being the property occupied by the Congregation of Jehovahs Witnesses.
 - d) **Roll Number 00950.000**

Lot 3, District Lot 473, Plan 3074, Osoyoos Division Yale District, except the westerly 50 feet; this being the property occupied by the Free Methodist Church of Canada.
 - e) **Roll Number 01027.005**

Lot 1, District Lot 473, Plan 31062, Osoyoos Division Yale District; this being the property occupied by St. Stephen's Anglican Church, excepting the following:

Commencing at a point 50.5 metres north of the southwest corner thence 33.5 metres easterly, parallel to the southerly property line, thence 30.48 metres northerly, parallel to the westerly property line, thence 33.5 metres westerly, parallel to the southerly property line, thence 30.48 metres southerly along the westerly boundary to the point of commencement; with such area containing approximately 0.252 acres, and the St. Stephen's Anglican Rectory.

Division Yale District; this being the property occupied by the Summerland United Church.

Lot "A", District Lot 3640, Plan KAP57534, Osoyoos Division Yale District; this being the property occupied by the Congregation of the Summerland Baptist Church.

n) **Roll Number 02620.200**

Lot 1, District Lot 3640, Plan 41467, Osoyoos Division Yale District; this being the property occupied by the Okanagan Similkameen Health Region (Kelly Care Centre).

o) **Roll Number 2631.500**

Lot 1, Plan KAP 56127 D.L. 3754 Osoyoos Division Yale District; this being property occupied by the Glenfir School Society.

2. This bylaw may be cited for all purposes as 'Bylaw Number 2000-223, General Statutory Tax Exemptions, 2006.'
